



Request for information on the National Personal Insolvency Index (NPII) to be suppressed or corrected

Bankruptcy Act 1966, Bankruptcy Regulation 13.04

Use this form to request certain information on the NPII, such as your address, be suppressed (that is, it will not be accessible by the public). You cannot request your name or date of birth be suppressed. This form can also be used to correct inaccurate or misleading information on the NPII.

The Official Receiver (AFSA) will only consider a request to suppress information in **very limited circumstances** (for example, where a domestic violence order or apprehended violence order has been granted, or you are in a witness protection programme). You must also include evidence to support your request.
